- 2.Candidate must show all original documents (from Class X level to Graduation(Honours)/Post Graduation level, Caste Certificate [in case of SC/ST/OBC A & B candidate], CAT /MAT / JEMAT or any other national level admission test Score along with self attested photocopies of all documents at the time of admission.
- 3. Each candidate must also submit 2 recent colour passport size photos at the time of admission.
- 4. Admission is Provisional.
- 5. Admission of the candidates from other than University of Calcutta is subject to the approval of the Equivalence Committee under the Registrar, University of Calcutta.
