Honours or Honours with Research courses of Studies) and Three-year B.Com. Courses of Studies under CCF,2022, under this University, as laid down in the accompanying pamphlet.

The above shall take effect from the academic session 2024-2025.

Amendments in CSR/06/2023, dt. 23.06.2023 (Admission Regulations for Three-year & Four-year B.Com courses of Studies under CCF, 2022) and subsequent corrigendum, dt. 30.06.2023:

#### Clause 4(a) of CSR/06/2023 dated 23.06.2023 will be read as :-

4.(a) A candidate who has passed the Higher Secondary (10+2) or its equivalent Examination is eligible to seek admission to the 1st year of the Four-Year B.Com. Honours or Honours with Research / Three-Year B.Com. Degree Course of Studies provided he/she has also passed in English having full marks not being less than 100 and fulfils the conditions as laid down in clause 4 and 5.

A candidate shall be allowed to take up B.Com. 3-Year Course of Studies, if he/she had passed the subject(s) at the previous qualifying examination as mentioned below:

Accountancy/ Mathematics/ Economics/ Commerce/ Business Studies/ Commercial Law and preliminaries of Auditing/ Costing and Taxation/ Computer Applications/ Informatics Practices/ Entrepreneurship.

Students who have passed the Higher Secondary (10+2) **Vocational Examination in Business and Commerce** conducted by the West Bengal State Council of Vocational Education and Training shall be eligible to seek admission to the first year of the **three-year B.Com course of studies** under this University.

However, no candidate shall be allowed to take admission after a lapse of more than 3 years from the year of passing the previous qualifying examination.

(Explanation: The year of admission shall not be taken into account while calculating three years from the year of passing the previous qualifying Examination).

### Clause 5(c) of CSR/06/2023 dated 23.06.2023 will be read as:-
