
Notification No. CSR/ 18 /14

It is notified for the information of all concerned that in terms of the provisions of Section 54 of the Calcutta University Act, 1979, (as amended), and, in exercise of his powers under 9(6) of the said Act, the Vice-Chancellor has, by an order dated 20.05.2014, approved change in the nomenclature of the course *Master of Visual Art (M.V.A.)* to Master of Fine Art (M.F.A.) imparted in *the Government College of Art & Craft, Calcutta* under this University.

The new nomenclature will be effective from the session 2014-2015 and onwards, while the syllabus will remain the same. Those who have already got themselves admitted in the Master degree (both in Part-I & II) will continue as M.V.A.

It is further notified that the Vice-Chancellor has also approved certain amendments in the Regulations notified in the Notification no.CSR/34/98 dated 06.11.1998, as laid down in the accompanying pamphlet.


As per the suggestion of the Board of Studies, following proposals for amendment to the C.S.R /34/98 of the Master Degree are given below:

- The practical examination shall be conducted jointly by a set of examiners (at least One External & one Internal Examiners) in both Part – I & part – II in each part.
- A candidate in order to qualify should obtain at least 40% of marks in Theoretical and 40% marks in the Practical examination.
- A student will be permitted to sit for the examinations in post graduate level as a regular candidate if he or she attends 75% of the total classes in a session.
- Students having percentage bellow 75%, but above 60%, will have to apply for condonation to the Vice-Chancellor, University Calcutta after paying the condonation fee for non-collegiate candidates as per regulation of the University .
- Students having percentage bellow 60% will be declared as discollegiate students.

Two new clauses have been proposed for inclusion in the C.S.R in the meeting for incorporation viz

- Eligibility of examiners – College Teachers of any U.G.C affiliated Art Institution/Eminent Artist (Five Years Diploma from G.C.A.C or M.F.A./M.V.A from recognized University)/ Subject Expert – Minimum Ten years experience from reputed company /Ad agency (I.E.N.S) / Textile Industry / Ceramic Industry/Interior Design agency. In case of examination in History of Art, eligibility criteria will be the doctoral degree or scholarly activities in Post –Master’s Level in the relevant subject or minimum 3 years Teaching experience in any College or University in the field Art Theories.
- The percentages of the elective /provisional / special classes will also be treated as regular classes from now on.

These Proposals for amendment of Master of Visual Art course of study are to be effective from the academic session 2014-2015.
