6. I will take re-admission/ permission for extension of stay in the CU-run Halls following CU-rules.
7. I undertake to conduct myself as a diligent student and boarder within the hostel and in the vicinity and will not misbehave in any manner including using inappropriate language, gesture with the CU-Authority, Hostel In-charge and other inmates and employees of the hostel
8. I will not create disturbance of any sort inside the hostel.
9. I will abide by the mess rules and timings as prevalent in the CU-run Halls and will regularly clear dues of the Mess, in time
10. I will show proper respect to the CU-Authority, the Superintendent/Assistant Superintendent and to all staff members of the office of the Board of Residence and CU-run Halls
11. I will maintain cordial relations with everyone inside the hostel.
